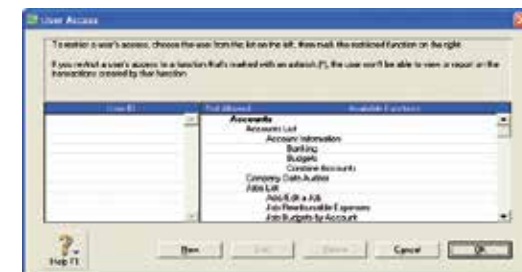


Multi-user access

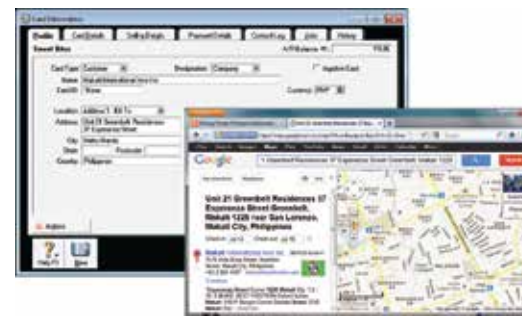
